Erika McDonald stated she feels that we do a fairly good job at this. Amanda and Tiffany have a great open-door policy on people that has specific concerns.

Jan Schwindt stated she has been in Tahitian for eleven years and has been involved with the Board in some way or another since moving here. She is ready to jump back in and support the community however, she can. She thinks the way we can support the community is to be good partners with the Water District, Water Board, Road Committee, ACC and our Commissioner. That is where we can

make some traction. Getting the roads done would be a big accomplishment and be supportive of our members and continue to support those entities. It's one team, one dream. She knows how important the POA is in keeping our neighborhood to a level that is not downhill and continuing to uphold the deed restrictions and guidelines that are in place.

Stacy Savage asked Jan Schwindt based on your experience what could you bring to the Board now then what you did previously?

Jan Schwindt answered history and the links we have had with the different entities.

Heather Norie started that she and her husband moved here a little over a year ago and quickly got involved through Lois Hornbuckle. She has been involved with Clean Sweep and has attended POA and ACC meetings.

She thinks she will bring to the table passion and being a good steward to the land. She feels that you need to know more than the deed restrictions and guidelines, you need to know why. She wants to bring new ideas to the table.

Jo Egitto wants to speak in general and thank the Board and candidates. The candidates bring a lot of value things to the table and there is a decision to be made. Tahitian is growing and hearing what you all are passionate about is great. It would be nice to hear what our POA short term goals would be. You all have a tough decision to make.

Stacy Savage asked Heather if she had any ideas on how to further engage the community?

Heather Norie answered she doesn't do Facebook often and stays away from the Tahitian Village sites. She doesn't want her judgement clouded. She is a very personable person and will get out meet people. If you need her to get out and talk to people, she will do it. She thinks it better if you are more personable.

Mary Jo Creamer asked if residents contact you personally about a situation, what would you do?

Heather Norie stated she would ask questions and would get all of the information. She would then talk to the builder, get the questions answered.

Jan Schwindt stated she would listen to the initial problem and then direct them to the Office. Since that is what the rule is, and we need to have one constant and that is to direct them to one person.

Erika McDonald stated she would get as much information and then tell them to contact Amanda. She would also state she is only one voice on the Board.
