## **Open Forum/Public Comment:**

Jo Egitto has some concerns that build sites are being viewed by Committee members before being signed

There is a site in Unit 2 that they took the top of the hillside and then the tri-plex on Koloiki with possible drainage issues. Is there any additional information that we can get from the County since they are approving these permits?

We have crazy geography and getting crazier builds on not easily buildable lots and are we getting all the information we can from all the sources? The ACC have a challenging job and has an onus at looking into this.

Randy McDonald stated he agrees to this. He said the new guidelines will help with this.

Amanda Craig said the newer guidelines provides new steps earlier in the process and hopes this will help.

Pierre Wilson states the road at the intersection at Akaloa and Wahane is crumbling and needs some work. Amanda Homesley asked if he or anyone has reported it. He stated, not that he knows of. Amanda Homesley stated we will send an email out to both entities.

1. April financial report

Jeremy then goes outside and shows the fence

Amanda asked do you own both properties on either side of you?

Because if someone does build, then it would be viewable from both sides of the street.

Jeremy Snyder, stated, no, I do not.

Amanda then stated that the guidelines state if you replace more than

50 % of your fence then you have to abide by the current guidelines.

Jeremy states but I am paying for my fence.

Joe Schwindt stated I dispute that.

Randy McDonald stated we need to take this into Executive Session because it sounds like there is going to be some Committee discussion.

5. Misc. Discussion and possible action on donation request for July 4<sup>th</sup> celebration.

Joe Schwindt made a motion to make a donation in the amount of \$250 for the July 4<sup>th</sup> celebration but to hold the \$ until June 19<sup>th</sup> contingent on the POA's decision. Pierre Wilson seconded the motion. A vote was taken, and the motion passed unanimously.
