Secretary's Report:

Pierre Wilson made a motion to accept the September 14, 2020 meeting minutes. Marty Burnett seconded the motion. A vote was taken, and the motion passed.

Open Forum/Public Comment:

Courtney Kellogg stated the new guidelines are not being enforced prior to September 1st. She was told that they were things that could not be enforced. She had the guidelines reviewed and they could be enforced daily. This is conflicting information. What specifically did the lawyer say on why we cannot fine daily?

Tiffany Ferguson stated your version of not following the guidelines are different than someone else's. Courtney Kellogg references posting of permits and not fining them.

Randy McDonald stated we are always questioning things constantly and trying to improve the guidelines. Do you have an attorney? Courtney stated no but has spoken to someone in professional contract writing. I am not against you guys. She feels she gets kick back from us. Why aren't they held accountable? Amanda Homesley stated she wants them removed from building. Courtney stated, that's not true and wants them to be respectful in the building process and too uphold the process and the ACC to work with the residents.

Amanda Homesley stated that last week when they were touring the homesites, they were almost spotless. Courtney Kellogg stated that they poured paint onto the property and that the foreman was on camera throwing it on the lot. Randy McDonald stated that this is a criminal act.

Courtney Kellogg once again stated that the 2015 guidelines are enforceable to fine everyday. Maybe we should ask Mr. Bragg about this because they continue to do things. Marty Burnett said there is a break down of communication. Sounds like you are more constringent on things than we are. We are not allowed to tell you when builders are fined, and your complaints are not as valid as some of the other ones. Courtney Kellogg doesn't understand the "interpretation" of things. Marty stated you want black and white and its not that way. Randy McDonald stated we are going to stop this conversation and look at all the emails that has transpired this far and will be back on next months agenda.
