1. August Financials-

For August we had \$796.69 in interest along with \$5,126.77 in legal settlement money, \$8,900 in builder permit fees, \$1,200 in property owner permit fees, and \$1,000 in violation fines with a total of \$17,023.46 of income.

For expenses, some of which include \$300 for rent, \$93.22 in office supplies, \$102.61 for telephone, \$200 for the website, \$3,467.13 in payroll, and \$357.50 in legal fees giving a total of expenses of \$4,775.51 leaving us with a net income of \$13,570.08.

Kat Smith made a motion to transfer \$100k from Roscoe to a high yield cd for 6 month or a 1 year with Edward Jones whichever has a better rate. Eddy Plummer seconded the motion. A vote was taken, and the motion passed unanimously.
