### **SECRETARY'S REPORT**

1. Discussion and approval of the April 16, 2024, meeting minutes.

### TREASURER'S REPORT

1. Discussion and possible approval for the April 2024 financials.

Amanda Homesley stated that we had a total income of \$13,980.69. Transfer fees were \$13,526.00 and interest was \$454.69. For expenses, some of which include auto expenses of \$1,984.00 for insurance, truck maintenance for \$276.12 for inspection, registration and oil change, payroll \$3,727.61, hog trapping \$3,000 and legal expenses for \$591.25. Total of expenses for the month was \$13,424.20 leaving a net income of \$556.49.

Dann Zimmer stated that interest seems low.

Amanda Homesley stated it should be higher next month because we just moved money into a new CD.

Dann Zimmer stated what CD?

Amanda Homesley stated it was an Edward Jones CD and will have to get that information to you.

Dann Zimmer stated he would appreciate it if we could send it to him because no cd's were maturing.

Amanda Homesley asked Charles Brading the amount of that because you took care of that. Charles Brading stated I believe it was \$60 or \$65k.

Dann Zimmer stated but we didn't have any renewing.

I watched it very closely and had access to it but don't anymore. The next CD maturing was July.

Amanda Homesley stated I will get that information to you tomorrow.

Can I get a motion for the April financials since this is for May?

Dann Zimmer stated there is nothing on this stating there was a renewal.

Amanda Homesley stated we will wait and do it next month.

April financials were tabled.
