Treasurer's Report:

1. September Financials

For September, most of our income includes \$8,850.00 in builder permit fees, \$300 in property owner permit fees, and \$3,750 in violation fines, giving us a total income of \$12,903.78.

For expenses, to name a few, we had \$2,000 for a scholarship, \$300 for rent, \$4,057.09 in payroll, an audit for \$5,500, and \$200 for website fees. Total expenses were \$12,750.98, leaving us with a net income of \$152.80.

Eddy Plummer made a motion to approve the September financials. Aaron Sanford seconded the motion. A vote was taken, and the motion passed unanimously.

2. Discussion and possible action on expiring CDs.

Randy Hudgins stated that we have two CDs that have matured, I went today to check on interest rates. The short term at 6-months is for 3.70% and 1-3 years is 3.65%. I make a motion to do a 6 month and another at 1 or 1.5 years to spread them out.

Aaron Sanford made a motion to get a 6-month CD and a 1- or 1.5-year CD at Edward Jones. Eddy Plummer seconded the motion. A vote was taken, and the motion passed unanimously.
