1. October Financials

For October, most of our income includes \$9,196.15 in interest, \$9,750.00 in builder permit fees, \$600 in property owner permit fees, and \$2,000 in violation fines, giving us a total income of \$21,636.15.

For expenses, to name a few, we had \$3,625.50 for D&O insurance, \$300 for rent, \$4,329.54 in payroll, an audit for \$5,500, and \$200 for website fees. Total expenses were \$9,261.16, leaving us with a net income of \$12,374.99.

Aaron Sanford made a motion to approve the October financials. Eddy Plummer seconded the motion. A vote was taken, and the motion passed unanimously.
