Thank you for your interest in joining the Tahitian Village Property Owners' Association (POA) Board of Directors or the Tahitian Village Architectural Control Committee (ACC). *All documents are due no later than December 3, 2021*.

The POA Director positions are filled for a term of two years. The POA Board of Directors meets once a month at 7 p.m. on the third Tuesday of each month. In addition to the monthly meetings, we ask that Directors make themselves available for occasional meetings to discuss items that require immediate attention, time to volunteer at Clean Sweep, and the ability to respond to correspondence via email in a timely manner.

The ACC Member positions are filled for a term of two years. The ACC meets once a month at 5:30 p.m. on the first Monday of each month. In addition to the monthly meetings, we ask that ACC Members make themselves available for occasional meetings to discuss items that require immediate attention or to work on additional ACC protocols, including the ability to respond to correspondence via email in a timely manner.

Once you have fulfilled all the required components to file your candidacy, please submit your completed application to the Association Manager. If you are running for a position on the POA Board of Directors or the ACC during an annual election, the Association Manager will submit your application to an Election Committee for vetting. If you are submitting your application to be appointed to fill a vacancy, the Association Manager will review your application for completeness and submit your application to the Board or ACC for appointment consideration.

If you are not elected or appointed to fill a vacancy and wish to rerun for a Place on either the POA or the ACC, you will be required to complete and submit a new application.

A person is ineligible to serve in any officer position or hold signatory duties if that person has been convicted of or plead *nolo contendere* to any offense involving burglary, theft, larceny, embezzlement, fraudulent conversion or misappropriation of property.

Any individual with a felony conviction is ineligible to serve on the Board or ACC. An applicant with two or more misdemeanor convictions, within 10 years prior to nomination deadline, is

ineligible to serve on the Board or ACC. A person deemed ineligible to serve under this section may request that the Tribunal reconsider that determination for good cause shown. A person is ineligible to serve in any capacity at any time on the Board, the ACC, or on any Association committee if he or she has been convicted of or plead nolo contendere to any violent or sexual crime. No reconsideration shall be allowed absent proof of mistaken identity or that there was no conviction or *nolo contendere* plea.

Once elected, all Directors and Committee Members must submit to an FBI Identity History Summary Check (IdHSC), at the Association's expense. If convictions are realized, as described above, the information will be sent to the Tribunal for review and assessment.

If you have any questions about completing the application, or the overall application process, please contact the Association Staff.

The required documents must be delivered to the Association by the stated deadline using one of the methods referenced below. The Association will transfer the candidate packet to the Election Committee. Candidate packets may be submitted by:

All documents are due no later than December 3, 2021. Please include all required documents, as stated in Article VIII Section 3 of the Bylaws, in order for your candidacy for POA or ACC to be considered.

- 1. The Candidate Nomination Packet must be complete and includes:
 - a) Candidate Member Profile form obtained from the Association or Association's website.
 - b) A Candidate's Petition for Support must include written support from a minimum of ten individual Members in Good Standing, not including self, without duplicate signatures or addresses.
 - c) The Petition for Support will include:
 - First and last name, legibly printed, matching their deed or the trust name if applicable. Middle name or initial inclusion or exclusion will not be considered for validation.
 - ii. Full property or legal address
 - iii. Phone number to be reached by Election Committee
 - iv. Email address to be reached by Election Committee (optional)
 - v. Legal signature to include first and last name, at minimum.
 - d) Proof of ownership in Tahitian Village by Warranty Deed or Certificate of Trust.
 - e) A brief biography, 250 words or less.
 - f) Texas DPS Criminal History Record.
