HOW to bring it:

√ For faster / easier unloading, place wide end of the stem facing the tailgate or the back of the trailer

Do NOT bring:

- X Cactus, yucca, palm fronds, or vines
- X Pine needles or leaves
- X Grass clippings or weeds
- X Construction material
- X Trash or bagged material of any kind

ITEMS MUST BE CLEARED OF:

- X All foreign material: Nails, Screws, Wire, Twine, ect.
- X Poison Ivy

Annual Meeting Notice & POA/ACC Openings

The Annual Meeting of the Tahitian Village Property Owners Association is scheduled for Saturday, January 28, 2023 at 1:00 pm. The location of the meeting is Best Western, 107 Hunters Crossing Blvd, Bastrop, TX.

At this meeting, we will go over our Annual Reports and hear from various speakers from our community. Results of the three positions on the POA Board of Directors and the two positions on the Architectural Control Committee will be announced.

If you are interested in serving your community either on the POA or ACC, the deadline for candidate registration is December 2, 2022.

POA Directors serve for two years. The POA Board meets once a month on the third Tuesday of the month at 7:00 p.m. and at the Annual Meeting of the property owners.

There are other meetings throughout the year that may require your attendance and many events that you will have the opportunity to attend voluntarily.

Architectural Control Committee members also serve for two years. The Committee meets once a month on the first Monday at 5:30 p.m. Committee members may be asked to attend additional meetings to work on Building Guideline revisions and all Committee members must be available to review permit applications frequently in the Association office.

All candidates will be vetted by the Election Committee. Please include *all* required documents, as stated in Article VIII Section 3 of the Bylaws, for your candidacy for POA or ACC to be considered. If you need a copy of the Bylaws, please contact our office at 512-321-1145.

All candidates must be property owners in Tahitian Village and all candidates will be vetted even if no election is needed. An election is not required if the number of candidates is equal to the number of vacant positions.

What is the difference between TVPOA, TVACC and BCWCID#2?

TVPOA

The Tahitian Village Property Owners Association (TVPOA) is responsible for maintaining and enforcing the deed restrictions in the five units that comprise Tahitian Village subdivision. Most of the POA's annual income comes from transfer fees.

TVACC

The Tahitian Village Architectural Control Committee (TVACC) is responsible for accepting, reviewing, approving or denying permit applications for new structures. Although it has its own board of directors and separate finances, TVACC operates under the general umbrella of the TVPOA. Most of the ACC's income comes from permit fees and fines against builders.

BCWCID#2

The Bastrop County Water Control and Improvement District #2 (BCWCID),known as the Water District, is responsible for roads, water and sewer in Tahitian Village.
