Are you ready for some warmer weather? You know what that means..... Spring Cleaning! It's that time of year when we trim our trees, cut our grass and clean our flowerbeds. We tackle our garages, storage buildings, attics and closets to get rid of things we no longer need and to get ourselves organized!

We hope you will donate any usable items to Bits and Pieces which benefits the Family Crisis Center. Profits generated by donations and patronage of Bits and Pieces support the mission of eliminating domestic and sexual violence in Bastrop, Colorado, Fayette and Lee counties.

Then, on April 12th we will host our quarterly Clean Sweep event at 112 Corporate Lane from 9:00 am to Noon (Don't forget this is a great opportunity to volunteer for your community, and meet some of your neighbors!).

Springtime is also a great time to get out in our community and do some exploring. You can start right here in Tahitian Village by enjoying the 2 miles of hiking trails at the Colorado River Refuge. This 65-acre nature area is managed and maintained by Pines and Prairies Land Trust, and is a true community gem. Then you can hop across the highway and enjoy a picnic or hike at the Bastrop State Park or Buescher State Park.

There are lots of fun springtime festivals to check out:

- Sherwood Forest Fair in McDade is open weekends from March 1st through April 20th.
- The Festival Concert Hall in Round Top will host the James Dick Piano Recital on Saturday, March 8th at 3:00 pm. Mr. Dick, a world-class pianist will delight you with his music and share the international center for music and learning that he created.
- The Bluebonnet Festival in Chappell Hill will be on April 12th and 13th.
- The Bastrop Opera House has a fantastic spring lineup with Urine Town running from February 21– March 9th; Lend Me a Tenor from March 28 April 6th; and A Gentleman's Guide to Love and Murder from April 25th to May 11th. # NEIGHBOR SPOTLIGHT...

Have you met Maggie Abbott or seen her around the Village?

Maggie is our "go-to" person whenever we need donations loaded up and taken to the Bastrop County Animal Shelter, and she's always willing to show up and help with our Clean Sweep events. But, Maggie's biggest passion is volunteering for the Bastrop Animal Shelter and Bastrop CATS!



At any given time Maggie's home is filled with foster cats and kittens awaiting their forever homes. Tiny kittens often need to be bottle fed and require special medical attention, and all of the fosters need to be loved and socialized. It's no small chore to care for and socialize these little bundles of fur, joy and energy!

Maggie is passionate about our feral cat problem, and is often out and about in the Village trapping feral cats so they can be spade and neutered, vaccinated and chipped. She believes that every cat and dog should be spayed or neutered to reduce the number of unwanted animals that are sadly being euthanized due to over crowding in our shelter. It's a huge problem in Bastrop County, and education is the key. She says, "people have to understand that this is everyone's problem, and as a society we can no longer turn a blind eye."

So, Maggie is on a mission! A group she is working with, of some dedicated volunteers, recently met with Bastrop County Commissioner, David Glass to discuss increasing public awareness, expanding kennel space, the need for more funding for low-cost spay/neuter programs, vaccination, microchipping and medical care for sick and injured animals. They also discussed ways our Assistant District Attorney can successfully prosecute animal cruelty.

Then, Maggie took it a step further and spoke at the bi-monthly meeting of the Bastrop County Commissioners Court. Maggie made an impassioned 3 minute speech to the judge, commissioners and attendees. She said that average pet ownership in the United States is 66%, so that would mean we have approximately 73,113 pet owners in Bastrop County. The American Veterinary Medical Association reports that there are 1.8 cats and 1.46 dogs per U.S. household meaning that in Bastrop County we have approximately 131,604 cats and 106,746 dogs in our County. Too many times these cats and dogs are not spayed and neutered and unwanted litters of puppies and kittens sadly end up in the shelter or killed by other animals or by accident. This is a tragedy that does not have to continue. Responsible pet ownership and educating our children how to be responsible pet owners is a great step toward ending this cycle.

Next, Maggie will be meeting with Bastrop City Manager, Sylvia Carrillo, to discuss these same issues and concerns. Maggie, the Bastrop County Animal Shelter and Bastrop CATS would love your support and encouragement to find lasting solutions to these serious issues.

As a community, we are proud that Maggie is part of our Village, and proud of her commitment and dedication to our furry, 4-legged friends. Keep up the good work!

#### Hello Neighbors.

Just a reminder that the Architectural Control Committee is here to help you with your Spring projects!

Any type of addition such as a shed, patio, pergola, pool, retaining wall or outdoor kitchen will need to be permitted through Bastrop County or the City of Bastrop depending on where you live, and the TVACC.

Fences must be permitted through TVACC.

Permits should be obtained prior to any work being started. This will save you time, money and headaches. Please call our office staff at 512-321-1145 for assistance.

This event is for Tahitian Village and Pine Forest residents only. Please be prepared to show proof of residency such as a driver's license or a bill showing your address.

Now is the time to get rid of any household items, debris, etc... that you no longer want!

Tires will have a \$4 per tire disposal fee.

- We cannot take old TVs with monitors, computers/monitors.
- Refrigerators, freezers and Air Conditioners must have the freon drained and must be tagged by a licensed technician or it will NOT be accepted for disposal at Clean Sweep.
- We also cannot take hazardous materials and paint cans must be completely dry (to dry the paint, add cat litter).
- We cannot accept household trash.

This is for bulk items that your weekly trash service can not pick up.

We gladly accept donations for the Bastrop County Animal Shelter - dog or cat food, kitty litter, blankets, towels, etc...

If you can assist in unloading your items, it would definitely be appreciated and it would help speed up the process.

# VETERANS' ASSISTANCE PROGRAM APPLICATION

The Tahitian Village Veterans' Assistance Program reimburses up to \$2,000 for a handicap accessible ramp to be built for U.S. Veterans living in Tahitian Village.

#### **Guidelines:**

- Must be a U.S. Veteran
- Tahitian Village must be your primary residence/homestead
- Either the veteran or his/her spouse must be disabled and in need of a handicap assessable ramp
- The ramp must be built by a licensed contractor or a certified organization
- Receipts must be provided to Tahitian Village Property Owners' Association along with this application to be considered for reimbursement
- All required permits must be obtained (City or County and TVACC)

#### Please provide the following along with this application:

- Proof of Military Service (please provide a copy of your DD214, Military ID, etc.)
- Proof that the Veteran or his/her spouse is disabled and in need of a handicap accessible ramp
- Receipts from a licensed contractor or certified organization showing the cost of the ramp
- Copy of the Bastrop County or City of Bastrop permit and the TVACC building permit

Once the application is received along with the required documentation, the TVPOA Board will review the application at the next regularly scheduled meeting. After that meeting, you will be notified if your application was approved or denied (or if more documentation is needed to make a decision) and when your reimbursement check will be ready.

# Colorado River Refuge News



Spring Migration has already started for Bastrop County. The trails along the river are full of the colors and songs of our birds.

During March and April Bird City Bastrop and Bastrop Audubon are offering several guided birdwatching outings for anyone interested in knowing more about our local birds. Loaner binoculars are available with instructions on their proper use. We will meet regardless of the weather forecast and decide our options based on the conditions at our location. We will also put up roadside signs leading to our meeting site.

Our first two outings will be at Bastrop State Park, from 8:30 to 10:00 am:

- On Friday March 14, we will have a Little Hike along the Army Trails just past the headquarters. These trails are paved for access to all.
- On Saturday March 22, we will have a Little Sit at the lake. Follow our signs to the meeting locations.
   We will sit a short distance from parking. You will want to bring a comfortable chair.

In April we will have both of our outings in Tahitian Village, from 8:30 to 10:00 am:

- On Friday April 11, a Little Hike will be held along the Cottonwood Kings Trail beginning in Bastrop County Park at 375 Riverside Dr. This trail is not paved but is flat and easily accessible.
- On Saturday April 26 we will have a Little Sit in Bastrop County Nature Park, 375 Riverside Drive, at the outdoor classroom area.

These outings are never just about birds. They are miniature nature classes that cover everything we see, hear and smell. You can count on it; they are always fun for all.

# PROTECT OUR MIGRATING BIRDS IN TEXAS

- Turn off non-essential lights inside and outside
- Turn off landscaping lights in trees
- If you need to prioritize, turn off lights during <u>peak</u> <u>migration</u>. Check bit.ly/Lights\_Out\_Texas for dates
- For essential lighting
  - Use dark sky friendly light fixtures or shields
  - Set timer or motion sensors
